Dear Parents:

Your son or daughter has expressed an interest in playing middle school tennis. I am writing to let you know that the Burlington Recreation and Parks Department and the Alamance Junior Tennis Foundation are sponsoring this program for the 16th year. This program works in conjunction with the school's athletic program, but is solely organized and funded by the AJTF. If your child participates in this program, please adhere to the following guidelines:

1. Players must participate for the school they attend.
2. Parents will be responsible for transportation to and from the matches.
3. Parents will be responsible to pick your child up promptly after practice.
4. Players, parents and family members will support the volunteer coaches.
5. Please sign the required liability waiver at the bottom and return to the coach.

Coaches are typically veteran tennis players who want to give back to our youth by volunteering their time. The Burlington Recreation and Parks Department have approved the coaches. All practices will be scheduled by the volunteer coach. Also, a schedule will be given to the coach once the teams have been determined. If there is a cancellation due to rain, it will be announced by 2:00pm that day through the school contact.

Matches will be held for five weeks on Friday afternoons starting in August. Players need to be at the scheduled location 10 minutes before match time. In order to participate, students will need a tennis racket and a good pair of tennis shoes. The Alamance Junior Tennis Foundation will provide balls.
